

**CAMBO, INC.**  
**RELEASE AND WAIVER OF LIABILITY**

I am aware that bicycling and other trail uses are athletic events which pose potentially serious risk of injuries or death to its participants. I understand that I may be injured or die as a result of my negligence, the negligence of others, or through no fault of myself or anyone else because of the nature of the activity in which I am going to be engaged. I also understand that traveling on off-road trails may be hazardous because of surface and weather conditions. With this waiver I accept notice of the risks involved in using off-road trails. **I further agree to wear an ANSI or Snell Certified helmet while riding at CAMBO, Inc. (CAMBO) affiliated activities.** The waiver shall remain valid unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by CAMBO, Inc. Furthermore, with this waiver I expressly assume the risk of injury or death due to negligence by CAMBO, its agents, employees, members, officers, directors, staff, and any landowners, their families, employees, or tenants over whose land I ride for my own safety or for the safety of my minor child.

With the knowledge of the foregoing, and as an inducement for CAMBO, Inc. to allow me to participate in CAMBO-affiliated activities, I hereby agree to forever waive or release any and all rights that I or my heirs may have to make a claim against CAMBO, Inc. or any members of its directors, officers, employees volunteers, members, and participants, or any landowners whose land I use, arising from any damages, injury, or death which I might sustain. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from CAMBO-affiliated activities. Furthermore, I agree to indemnify CAMBO, Inc., its directors, officers, members, or employees or any landowners, their families, employees or tenants, for any injury, death, loss or damage to any personal property which might occur during a CAMBO affiliated activity or held in its behalf or for its benefit, when such injury, death, loss or damage occurs on the property of a landowner.

BY SIGNING THIS WAIVER AND RELEASE, I UNDERSTAND THAT I AM GIVING UP, (WAIVING AND RELEASING) ANY RIGHT I MIGHT HAVE TO SUE OR MAKE A CLAIM WHICH I MIGHT HAVE OR WHICH MIGHT SUBSEQUENTLY ARISE OR OCCUR AGAINST CAMBO, INC. OR ITS MEMBERS AND PARTICIPANTS, OR ITS DIRECTORS, OFFICERS OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES OR TENANT, WHOSE LAND I USE, FOR ANY INJURIES I MIGHT SUSTAIN WHILE USING OFF-ROAD TRAILS OR PARTICIPATING IN A RELATED ACTIVITY, AND THAT I AM INDEMNIFYING AND HOLDING HARMLESS, CAMBO INC., ITS DIRECTORS, OFFICERS, MEMBERS AND EMPLOYEES, AND/OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES AND TENANTS, WHOSE LAND I USE, FOR INJURING ANYONE ELSE WHILE SO ENGAGED. IT IS MY INTENT TO GIVE UP THOSE RIGHTS AND PROVIDE THE HOLD HARMLESS AGREEMENT, AND I DO SO KNOWINGLY AND VOLUNTARILY.
